**COMMISSIONER'S ORDER NO.01/2020**

Sub: Cases registered under Section 376, 376A, 376AB, 376B, 376C, 376D, 376DA, 376DB or 376 E of the Indian Penal Code (45 of 1860) shall be completed within two months.

It has come to our notice that Investigating Officers (IO) of different Police Stations of the Police Commissionerate, Bhubaneswar-Cuttack are not submitting Final Form in the court within the period of two months from the date of registration of FIR for the offence under Section 376, 376A, 376AB, 376B, 376C, 376D, 376DA, 376DB or 376 E of the Indian Penal Code (45 of 1860), in gross violation of the provisions of Sec. 14 of the Criminal Law (Amendment) Act, 2018. The said Act inserted section 173(1A) in Criminal Procedure Code 1973 for submission of Final form in the court of law within a period of Two Months in respect of investigation of rape cases.

The Hon'ble Supreme Court of India in SMW (CRL.) No(s).04 of 2019 dated 18.12. 2019 vide Para No.15 has also directed each state of Union of India to implement the mandate of the Act in respect of the aforesaid offences of Indian Penal Code.

In view of the above, it is hereby directed that all IsIC/IOs of the Police Commissionerate, Bhubaneswar-Cuttack must ensure submission of Final Form u/s 173(1A) of the Cr.P.C 1973 in the court within the period of Two Months from the date of registration of the aforesaid offences under Indian Penal Code.

In case Final Form (F.F) could not be submitted within the said stipulated period, then IO should submit prayer before the Competent Court stating therein sufficient reasonable ground for extension of time for submission of Final Form.

The DCsP of both the UPDs are requested to ensure timely and prompt supervision of such cases within the time framed, so that IO can submit Final Form within the period of Two Months as directed under the law.

Failure in submission of Final Form (FF) in such cases within the stipulated period without any valid ground is contempt of Court, and violation of legal mandate of the statute. Action as deem proper will be taken against those officers with whom such delay is noticed.
