

**(DETAILED GUIDELINES FOR THE POST OF LAW OFFICER IN THE OFFICE OF  
COMMISSIONER OF POLICE, BHUBANESWAR-CUTTACK, BHUBANESWAR)**

Applications in plain paper as per the enclosed proforma are invited from the intending candidates from Retired District Judge/Retired Addl. District Judge/Retired Public Prosecutor/Retired Addl. Public Prosecutor having degree in Law (LL.B/LLM) and with sufficient experience in handling LEGAL matters especially in Criminal Acts & Rules for engagement as **LAW OFFICER** in the office of the Commissioner of Police, Bhubaneswar-Cuttack, Bhubaneswar on contractual basis. Engagement will be made as per the guidelines issued in General Administrative Resolution No.23750/Gen. Dtd.27.08.2014 and S.P. Hdqrs. Letter No.502/OP. Dtd.18.02.2022. Payment of consolidated remuneration will be made as per Government guidelines.

**ELIGIBILITY CONDITION:**

1. Officers who have retired from Government service on attaining the age of superannuation and below the age of sixty three years having good service records and are physically fit shall be eligible to be considered for engagement.
2. Officers against whom no departmental proceedings or criminal cases are contemplated/pending or who have not been penalised for misconduct during the period of preceding five years will be eligible for consideration.

**TERMS AND CONDITIONS:**

1. The above engagement is valid for a period of two years and can be extended for subsequent period of two years with spells of one year each subject to satisfactory performance upto a total period of four years not

beyond the age of sixty-five years of age in any case or till the post is filled up by a Law Officer on regular basis, whichever is earlier.

2. The engaged officer shall be governed by the provisions of Odisha Government Servants' Conduct Rules, 1957 and shall be liable to be proceeded against for their misconduct, omissions and commissions as per the provisions under the Odisha Pension Rules, 1992.
3. Engagement can be withdrawn at any point of time by the Appointing Authority due to unsatisfactory performance by giving one month notice. On the contrary, engaged officer can resign by giving one month's written notice to the Appointing Authority.
4. The engaged officer will furnish an undertaking at the time of joining the duty with regard to the veracity and correctness of the information.
5. The Competent Authority deserves the right to reject or cancel any or all applications without assigning any reason thereof.

**SELECTION PROCESS:**

Applications received within the due date will be scrutinised by a Selection Committee and the short listed applicants will be required to appear before the Selection Committee for an interview and selection.
